"What's the Answer?"

Q. A player goes over the foul line while retaining possession of the ball, is this considered a foul?

A. No. A legal delivery must be executed for a foul to be committed. A legal delivery is made when the ball leaves the player's possession and crosses the foul line into play in territory.

Q. When can an approved cleaner be used on a bowling ball?

A. Unless otherwise provided by league or tournament rule, cleaners approved by the USBC can be used on bowling ball at any time during USBC competition. For a complete list of approved and non-approved cleaning agents, see bowl.com
