TOURNAMENT RULES

1. Eligibility – Only members of the Union County NJ USBC over the age of 50 at time of bowling, are eligible to compete in this tournament. Non-Members living within the jurisdiction of this Association who are not members of another association may enter by paying associate dues (USBC BA. \$20.00 USBC WBA. \$21.00)
2. This will be a handicap singles tournament, 100%, based on 230 without any limit.
3. There will be three (3) classes of competition: Class A – 180 & up; Class B – 140 to 179; Class C – 139 & lower.
4. Averages will be used in the following order based on a minimum of 21 games in an USBC-certified league in Union County:
 - a. 2010-2011 winter season
 - b. If no 2010-2011 average use 2011-2012 average as of March 18, 2012.
 - c. Bowler lacking any of the aforementioned averages must enter at 230**NOTE: SUMMER LEAGUE AVERAGES WILL NOT BE ACCEPTED**
5. USBC Rule 319A – 2 (10 pin Increase in Current Average Rule): Waived for this tournament.
6. USBC Rule 319-A3 shall apply: It shall be each bowler's responsibility to verify the accuracy of his/her average in this tournament. Failure to use proper average or make a correction prior to the completion of the first game shall disqualify the entry if a submitted average is lower than the correct average. When an average is submitted higher than it should be, and is not corrected up to completion of first game, prize winnings shall be based on the submitted average.
7. USBC Rule 319D – Reporting of Prizes: Waived for this tournament.
8. USBC Rule 319E – Rerating Rule: Waived for this tournament.
9. The prize ratio shall be at least one in five.
10. The Tournament Committee reserves all rights.
