TOURNAMENT RULES

ELIGIBILITY

Only members of the Union County NJ USBC are eligible to compete in this tournament.

(Jersey Lanes, Linden Lanes, Garwood Lanes, Lucky Strike, North Brunswick, Majestic Lanes and Circle Bowl and Entertainment)

All entrants must produce their USBC certification card.

If making payment by Zelle, Check or Cash, the application and payment must be received at the Union County NJ USBC Office prior to the closing date of the Tournament to be accepted.

AVERAGES

- A. Highest certified 2024-25 Union County average of 21 games or more.
- B. If "A" does not apply, a bowler must use their highest February 1, 2026, certified Union County average, minimum 21 games. Verification must be presented with application
- C. If "A" or "B" does not apply, a bowler must use a scratch average of 230.
- D. ***Summer league or USBC Youth averages will not be accepted.***

MULTIPLE ENTRIES

- A. In no case shall a Team place more than once with the same Bowlers.
- B. A Bowler may only place once in the Singles Event Prize list.
- C. Entries based on Lane availability

RULES

USBC Rule 319A-3 shall apply: It shall be each bowler's responsibility to verify the accuracy of his/her average whether originally submitted by the bowler, his/her team captain or others. Failure to use the proper average or make a correction prior to the completion of the first game bowled of the series shall disqualify the scores if the submitted average is lower than the actual average or base prize winnings on submitted average if it is higher. USBC Rule 319A-1B (use of composite average), Rule 319A-2 (ten pin rule), Rule 319D (Report of prize winnings) and Rule 319E (Use average during 12-month period) are all waived. The Average Rerating Rule (USBC Rule 319-C) applies throughout this Tournament. This rule allows the Tournament Director to adjust the bowler's entering average. The bowler or bowlers affected have the right to appeal the re-rating.

PRIZES

Trios and Singles Events will be apportioned as follows: **60% for Handicap score prizes** and **40% for Actual Score prizes**. Should a Bowler/Team score qualify for both, the Bowler/Team shall receive the higher dollar amount of the two. Prize ratio is at least 1 in 10 for both Events.

BOWLER'S RESPONSIBILITY

The individual whose name appears on this entry form shall be responsible for the accuracy of all information submitted hereon. Any incorrect information or violation of Tournament Rules may result in the disqualification of the entire entry and forfeiture of entry fees as well as any resultant prize money.
