**RULES**

1. Eligibility – All USBC Members are eligible to compete. Non Union County NJ USBC members may enter by purchasing a Local Association Certification Card for \$10.00. No junior certified bowlers will be permitted to bowl.
2. Participants are entered in both scratch & handicap events by Class, eligible to win in both, once in handicap and once in scratch. Re-entries are permitted, entries close at the start of the last squad, Sunday October 28, 2018. Handicap will be 100% based on 230 average. Tournament will consist of 3 games bowled across 6 lanes.
3. Averages will be used in the following order based on 21 or more games.
  - a. Highest 2017-2018 Union County winter average.
  - b. If no "a", a bowler will use their highest USBC 2017-2018 Winter Average.
  - c. If none of the above applies, a bowler must use a 230 average.
4. USBC Rule 319A-3 shall apply. It shall be each bowler's responsibility to verify the accuracy of his/her average in this tournament. Failure to use proper average or make a correction prior to the completion of the first game, shall disqualify the entry if a submitted average is lower than the correct average. When an average is submitted higher than it should be, and is not corrected up to the completion of the first game, prize winning shall be based on the submitted average.
5. USBC Rule 319A-1(b) is waived (composite average), Rule 319 A-2 is waived (10 pin increase in current average), Rule 319D is waived (Reporting prior prize winnings), and Rule 319E is waived (use average during 12 month period).
6. Prize Fees will be returned 100% in each class. Ratio will be at least 1 in 10. Prize Fund is broken down in each class, 50% handicap and 50% scratch.
7. Tournament Committee reserves the right to cap the number of bowlers on a pair of lanes within the squad time.
8. Tournament Committee reserves all rights.

**\*Walk In is defined as paying for entry the same day as the event.**
